GENERAL DESCRIPTION OF POSITION

The Right of way Coordinator/Sign Crew Supervisor is under the general supervision of the Road Superintendent and Assistant Road Superintendent, the incumbent are to provide supervision to various areas of the Road Department, such as obtaining Right of way from residents for the purpose of improving the public roads. Be responsible for directing sign crew operations, surveying road right of way for road widening, and general improvements. The coordinator will provide recommendations to road superintendent regarding design of roads and the policies of the federal Highway Administration concerning Uniform Traffic Control Devices. The Right of Way Coordinator/ Sign Crew Supervisor will also be responsible for helping our construction crews establish effective surveys of roads, elevations, drainage, and general shape of road ways.

The Right of Way Coordinator position requires a high mental demand due to the volume of projects that will be processed and analyzed though out the county. This position requires direct contact with residences of Washington County on a daily bases. This position will require great communication and organization skills. The Right of Way Coordinator must demonstrate the ability to identify and analyze control data to ensure specification or land survey standards to salve problems in support of departmental objectives. The coordinator must plan and direct the work of geodetic surveying to calculate control networks using direct leveling or other geodetic survey techniques. This position will also require knowledge of sign placement and design, familiarity with a plotter in construction of signs and other control devices.

Responsible for equipment necessary to complete various jobs, ensure proper completion of each project, and maintain an accurate inventory of all materials. The incumbents are responsible for the supervision of employees and work crews to ensure efficient and accurate completion of all projects in a timely and safe manner.

ESSENTIAL DUTIES AND RESPONSIBILITIES

- 1. Responsible for the supervision of Sign crew and their daily duties.
- 2. Responsible for maintaining inventory of all equipment assigned.
- 3. Maintain records for each project assigned to include accurate hours worked per employee, machine hours operated, amount of oil used, loads of material used, and any other records required per specific project.

- 4. Investigate county road complaints made by individuals or organizations by inspecting the road and making a decision on how best to solve the particular complaint. Make recommendations to the County Road Superintendent, or Assistant Road Superintendent as necessary.
- 5. Verify permits given for utility work where bonds have been posted determine if the road has been satisfactorily repaired, and release the bond or contact the utility company to complete the permit process.
- 6. Check with individuals wanting driveway tiles, pricing tiles, and receive payment.
- 7. Perform routine and preventative maintenance on all equipment. This equipment is very diversified and requires extensive expertise and knowledge of mechanics, hydraulics, transmissions, and overall workings of a wide variety of machinery from many companies or sources.
- 8. Ensure that all workers are properly supervised and are given proper direction in the performance of their duties. Assign employees to specific tasks in the best interest of the road department and the County.
- 9. Ensure that all work is performed in an efficient manner for the construction, improvement or maintenance of County roads.
- 10. Ensure that all operations are performed in a safe manner to guard against accidents to fellow employees and the public at large.
- 11. Handle all emergency situations and repairs in a safe and efficient manner.
- 12. Ensure that an adequate inventory of tools, parts, and supplies are on hand for continuity of road department operations.
- 13. Ensure that accurate maintenance records are maintained for the field work.
- 14. Perform all liaison activities in a professional manner to ensure maximum cooperation between and among County and other agencies.
- 15. Regular attendance is required.
- Attendance maybe required during inclement weather and emergency situations.
- 17. This position will require working with GIS and IT personal.
- 18. Perform any other related duties as required or assigned.

QUALIFICATIONS

To perform this job successfully, an individual must be able to perform each essential duty mentioned satisfactorily. The requirements listed below are representative of the knowledge, skill, and/or ability required.

Each supervisor will be on call after normal business hours for emergency situations.

Minimum of high school diploma or general education degree (GED); eight (8) years previous experience in construction, operation and maintenance of heavy machinery. This position requires at least 4 years of working knowledge, in surveying and grade elevation operations. Must be able to operate all equipment need to survey and grade elevation, as needed to complete construction project's. Must be able to operate computer systems to create and interpret sight maps and elevation charts. Computer skills will be needed for most operations pertaining to this position.

The incumbents must possess considerable knowledge and/or experience in the repair of all types of machinery used by the Road Department. The incumbents must possess knowledge of machine operations used on the projects, general road maintenance knowledge, and accurate record keeping

ability for project tracking. The incumbent must possess knowledge of survey work, welding knowledge; parts identification and installation. The incumbent must be able to operate dozers, backhoes, graders, brush hogs, and dump trucks in order to fulfill the requirements for this position. The incumbents must possess effective supervisory ability. Must be able to communicate effectively with coworkers, supervisors, public and utility companies for certain projects. The incumbents are required to use a calculator, two-way radio, and a computer.

BE IT ORDAINED BY THE QUORUM COURT OF THE COUNTY OF WASHINGTON, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE AMENDING WASHINGTON COUNTY CODE SECTION 2-47 TO INCLUDE A PARENTAL LEAVE POLICY IN THE EMPLOYEES HANDBOOK.

WHEREAS, Washington County recognizes the importance of family relationships to its employees; and,

WHEREAS, Washington County further recognizes the need for a primary caregiver to bond with a child immediately after the child's birth or Placement for adoption; and,

WHEREAS, it is the desire of the Quorum Court to amend the personnel policy to reflect this recognition.

NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF WASHINGTON COUNTY. ARKANSAS:

ARTICLE 1. Washington County Code Section 2-47 is hereby amended to include the following Parental Leave Policy in the Washington County Employee Handbook:

PARENTAL LEAVE POLICY

Washington County is firmly committed to protecting the rights of expectant parents and complying with *Title VII of the 1964 Civil Rights Act* as amended by the *Pregnancy Discrimination Act of 1978* and *the Americans with Disabilities Act* (ADA). Washington County's policy provides eligible employees with a period of paid time off for activities related to the care and well-being of their newborn or adopted child. Parental leave may be utilized in conjunction with other paid and unpaid leave entitlements.

Washington County will provide up to eight (8) weeks paid parental leave to an eligible employee serving as a primary care giver following the birth or adoption of a child. The benefit amount will be base salary determined by regularly scheduled hours of work. Eligible employees must have been employed at least one (1) year and for at least 1,250 hours during the preceding 12 month period. This policy does not provide a benefit for guardianships, conservatorships or foster children.

Eligible employees who meet the service requirements must use the parental leave in the first twelve (12) weeks following the birth or adoption of a child. If both parents work for Washington County, then only one parent can be designated as a primary caregiver. Parental leave will be considered if it is applicable for the following reasons:

- the birth of the employee's child and in order to care for the child,
- the placement of a child with the employee for adoption

An eligible employee is defined as a natural parent or a new adoptive parent who is the primary caregiver. "Parent" shall be defined by state law. An individual who adopts a spouse's or partner's child(ren) is not eligible for this benefit.

A primary caregiver is defined as someone who has primary responsibility following the birth or the taking of the child into the custody, care or control of the parent(s) for the first time.

In all cases, the employee requesting leave must notify the supervisor of a need for leave. In addition, the employee intending to take parental leave because of an expected birth or adoption/placement must submit appropriate documentation (e.g. medical certificate, adoption decree, etc.) at least thirty (30) days before the leave is to begin, except in instances where such information is not reasonably available to the employee.

To ensure accurate and timely payment, the employee is responsible for submitting all of these forms to the HR office at least thirty (30) days in advance of the first day of leave. Parental leave will run concurrently with associated Family and Medical Leave. The employee must use his or her accrued vacation and sick time following the paid parental leave before going on a leave without pay status.

During a period of parental leave, an employee will be retained on the Washington County health plan under the same conditions that applied before leave commenced. To continue health coverage, the employee must continue to make contributions that s/he made to the plan before leaving. On an employee's return to work, premiums that are in arrears and due to Washington County will be withheld at twice the normal premium rate until the amount owed has been fully reimbursed.

When the employee returns to work, he or she is entitled to return to the same or equivalent job with no loss of service or other rights or privileges. Provided, however, that in the event of a layoff, reorganization, downsizing or other cases where the employee's position has been permanently eliminated for reasons not connected to his or her leave, the County has no obligation to reinstate the employee. Please note that Washington County cannot guarantee that an employee will be returned to his or her original job. A determination of whether a position is an 'equivalent position' will be made by Washington County.

If the employee fails to return to work for 30 days after the expiration of the leave, the employee will be required to reimburse Washington County for payment of health care premiums during the leave, unless the reason that the employee fails to return is the presence of a serious health condition which prevents the employee from performing their job or to circumstances beyond the employee's control. Standard FMLA certification rules will apply. Should the employee not return to work when released by a physician, they shall be considered to have voluntarily terminated their employment with Washington County.

NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF WASHINGTON COUNTY, ARKANSAS:

ARTICLE 1. Washington County Code Section 2.7-23(b) is hereby amended to read as follows:

(b) Potentially dangerous animals, while on the animal owner's property, shall be securely confined indoors or in a securely enclosed and locked pen or structure, suitable to prevent the entry of young children and designed to prevent the animal from escaping. Such pen or structure shall have secure sides be constructed in accordance with the U.S. Department of Agriculture standards, and must be a cage, fence, walled enclosure, building, or any other structure that is of sound construction and shall also provide room for adequate exercise and protection from the elements for the animal. The animal owner shall display signs warning of the dangerous animal along with a symbol for same easily seen by children. The signs displayed shall be easily seen from the public roadway.
