MINUTES OF THE REGULAR MEETING OF THE WASHINGTON COUNTY QUORUM COURT

Thursday, January 19, 2017 6:00 p.m. Washington County Quorum Court Room

County Judge Joseph K. Wood called the meeting to order.

JP Lundstrum led the prayer and pledge.

Quorum Court Secretary Carly Sandidge called the roll. Members present were JP Daniel Balls, JP Harvey Bowman, JP Rick Cochran, JP Robert Dennis, JP Lisa Ecke, JP Joe Kieklak, JP Roddy Lloyd, JP Tom Lundstrum, JP Sue Madison, JP Joe Patterson, JP Butch Pond, JP Bill Ussery. Absent were JPs Ann Harbison, Eva Madison and Joel Maxwell.

Following several amendments to the agenda, a motion to approve the agenda as amended was made by JP Cochran. JP Dennis seconded. The amended agenda was unanimously adopted.

A motion to suspend the rules and read all ordinances by title only was made by JP S. Madison. JP Dennis seconded. The motion passed unanimously.

During the citizen's comment, Jeff Hatley, Public Information Officer for Ozark Regional Transit provided an update on their facility. There was a fire on January 10, 2017 and destroyed 85% of their fleet. There was discussion from JP Ecke and JP Bowman. Lorraine O'Neal, a resident of Fayetteville, thanked the County Judge for running for office as she believes he will do a fine job representing the citizens of Washington County.

A motion to approve the December minutes was made by JP Ecke. JP Dennis seconded. The December minutes were unanimously adopted.

County Attorney Lester provided a copy of Powers and Duties of the Quorum Court, Freedom of Information Act, General Meeting Conduct, and Meeting Procedures to the Quorum Court.

JP Cochran introduced agenda item 8.1. County Attorney Lester read, by title only, "AN EMERGENCY ORDINANCE AMENDING ORDINANCE NO. 2015-64 CREATING A FINANCE AND BUDGET COMMITTEE." A motion was made by JP Cochran to pass the ordinance. JP Pond seconded. There was no public comment. A roll call vote was called and all members present voted to adopt the ordinance.

Ordinance 2017-01, AN EMERGENCY ORDINANCE AMENDING ORDINANCE NO. 2015-64 CREATING A FINANCE AND BUDGET COMMITTEE, was adopted.

Judge Wood presented a review of Quorum Court committee assignments for 2017-2018, and scheduling of meeting dates/time. A motion was made by JP Lundstrum and properly seconded to accept assignments and initial date/time. The motion passed by those present. The committees were adopted.

A motion was made by JP S. Madison to reappoint JP E. Madison to serve as the Washington County Quorum Court's representative on the Arkansas Association of Quorum Courts for the 2017-2018 term. JP Pond seconded. JP Cochran made a motion that nominations cease and they elect JP E. Madison to the Arkansas Association of the Quorum Courts by acclamation. JP Lundstrum seconded. The motion passed unanimously by those present. JP E. Madison was reappointed.

County Treasurer Bobby Hill gave the Treasurer's Report.

County Prosecutor Matt Durrett provided an end of year report on the Hot Check Fee Account.

County Judge gave his Judge's report. County Judge addressed a list of his Board appointment recommendations for the Planning Board, Rural Development Authority, Washington Water Authority, and Washington Regional Medical Centers as well as approval of the County Attorney. A motion was made by JP Lundstrum to approve the list of Board Appointments and appointment of County Attorney as drafted. JP Dennis seconded. There was discussion from several members. JP Ecke made a motion to amend Judge Wood's request, removing County Attorney Lester's approval until all information is provided. JP S. Madison seconded. Thereafter, JP S. Madison withdrew her second to JP Ecke's motion and JP Ecke withdrew her motion. There was no other comment. A roll call was made. The votes were tallied as follows:

The Board appointments and appointment of County Attorney was approved.

JP Pond introduced agenda item 14.1. The rules were twice suspended to advance the ordinance to a second and third reading. Following those readings by County Attorney Lester, a motion was made by JP Pond to adopt the ordinance. JP Cochran seconded. There was no public comment. A roll call vote was called and all members present voted to adopt the ordinance.

Ordinance 2017-02, AN ORDINANCE AUTHORIZING THE COUNTY JUDGE TO ENTER INTO A CONTRACT FOR SERVICES WITH THE ASSOCIATION OF ARKANSAS COUNTIES, was adopted.

JP Pond introduced agenda item 15.1. County Attorney Lester read, by title only, "AN ORDINANCE ANTICIPATING REVENUES TOTALING \$2,430,662 IN VARIOUS FUNDS; AND APPROPRIATING \$2,430,662 FROM VARIOUS FUNDS TO VARIOUS BUDGET LINE ITEMS FOR 2017." A motion was made by JP Pond to adopt the ordinance. JP Cochran seconded. There was no public comment. A roll call vote was called and all members present voted to adopt the ordinance.

Ordinance 2017-03, AN ORDINANCE ANTICIPATING REVENUES TOTALING \$2,430,662 IN VARIOUS FUNDS; AND APPROPRIATING \$2,430,662 FROM VARIOUS FUNDS TO VARIOUS BUDGET LINE ITEMS FOR 2017, was adopted.

JP Pond introduced agenda item 16.1. County Attorney Lester read, by title only, "AN ORDINANCE APPROPRIATING THE AMOUNT OF \$998,111 FROM THE GENERAL FUND TO THE ASSESSORS BUDGET FOR 2017." A motion was made by JP Pond to adopt the ordinance. JP Ecke seconded. There was no public comment. A roll call vote was called and all members present voted to adopt the ordinance.

Ordinance 2017-04, AN ORDINANCE APPROPRIATING THE AMOUNT OF \$998,111 FROM THE GENERAL FUND TO THE ASSESSORS BUDGET FOR 2017, was adopted.

JP Pond introduced agenda item 17.1. County Attorney Lester read, by title only, "AN EMERGENCY ORDINANCE RATIFYING A CONDITIONAL USE PERMIT GRANTED BY THE PLANNING AND ZONING BOARD"

for the Summers Missionary Baptist Church. A motion was made by JP Pond to adopt the ordinance. JP Patterson seconded. There was no public comment. A roll call vote was called and all members present voted to adopt the ordinance.

Ordinance 2017-05, AN EMERGENCY ORDINANCE RATIFYING A CONDITIONAL USE PERMIT GRANTED BY THE PLANNING AND ZONING BOARD, was adopted.

During "Other Business", there was discussion about the County's Employee Handbook; hiring practices; grievance hearing.

The meeting was adjourned.

ORDINANCE NO. 2017-01

BE IT ORDAINED BY THE QUORUM COURT OF THE COUNTY OF WASHINGTON, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN EMERGENCY ORDINANCE AMENDING ORDINANCE NO. 2015-64 CREATING A FINANCE AND BUDGET COMMITTEE.

WHEREAS, the Quorum Court recognizes that a Finance and Budget committee is critically important to the administration of the duties of the Justices of the Peace.

NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF WASHINGTON COUNTY, ARKANSAS:

ARTICLE 1. Washington County Code Section 2-22 is hereby amended to read as follows:

- (a) The following committees of the Quorum Court are hereby established:
 - (1) County Services;
 - (2) Jail/Law Enforcement/Courts;
 - (3) Personnel;
 - (4) Public Works; and
 - (5) Ordinance Review; and
 - (6) Finance and Budget.
- (b) Each committee shall provide for its own organization and management of its affairs, including the election of its own chair and vice chair.

ARTICLE 2. Emergency Clause: It is hereby determined that it is in the public's best interest for this ordinance to be effective immediately; and the general health, safety and welfare of the citizens are affected by such for the reasons as set out above; therefore an emergency is declared to exist and this ordinance shall be and is effective from the date of its passage.

Staff does not expect any appeals on this CUP and recommends ratification of the project.

Summers Baptist Church Youth Center is requesting Conditional Use Permit approval to add an approximately 8,500 square foot building addition to the Summers Baptist Church property. The proposed addition will house a gymnasium, restrooms, storage, laundry, and classrooms/meeting rooms. It is proposed to be connected to the Church building via a walkway and covered canopy. The parking area will also be expanded slightly to accommodate parking for this building. The hours of operations, the traffic volume, and the overall impact to surrounding properties will remain generally the same.

There is an existing septic system installed that is used by the existing church. Corbitt Environmental Consulting submitted a statement that they believe the existing septic system will be adequate to handle the additional usage by the proposed expansion.

The water provider is Lincoln Water. Firefighting operations will involve tanker support; tankers can fill at the intersection of Highway 59 and 62 to the northwest of Summers Baptist Church.

Architect plans are required. The Fire Marshal shall review and approve all plans before the plans are accepted, and before ANY construction can begin. As the architect will be creating an interior plan/layout that determines adherence to health/safety issues, fire code, and ADA accessibility, the design by the Architect, with respect to these issues, must be adhered to.

This project accesses off West Arkansas Highway 62; Young Road WC 460 borders the property to the south but does not provide access to the parking area. Sight distance was investigated at the time the initial church building was expanded and found adequate. The same entrance is proposed to be utilized for this building.

The surrounding uses are mostly large agricultural lots, some small and large residential and residential/agricultural parcels, and a vacant parcel. The project involves an existing church building that contains worship space and classrooms.

Staff feels the applicant's request will be compatible with the surrounding uses. There should not be an increase in noise, minimal increase in traffic, and generally will not disturb the surrounding properties.

All neighbors within 300 feet of the boundary of this property were notified by certified mail of this proposed project. No comments have been received. No comments were received by mail or voiced at the Planning Board Meeting.

Staff does not expect this to be contentious and recommended approval of the proposed Summers Baptist Church Youth Center/Gymnasium Conditional Use Permit with conditions.

The Planning Board/ Zoning Board of Adjustments approved (4 members voted "in favor", 0 members voted "against", 1 member was not present, 0 members abstained, and 2 vacancies exist on the board) the project with the following conditions:

Septic System Conditions:

- The proposal to connect to the existing septic system must be approved by the Arkansas Health Department (ADH), installed, and then inspected by ADH (if required by ADH) prior to occupation of the building.
- 2. No parking is allowed on any portion of the septic system including the alternate area. (No overflow parking either).

Water/Fire Conditions:

- 1. Any permits required by Lincoln Water must be obtained.
- 2. Architect plans are required. The Fire Marshal shall review and approve all plans before the plans are accepted, and before ANY construction can begin. As the architect will be creating an interior plan/layout that determines adherence to health/safety issues, fire code, and ADA accessibility, the design by the Architect, with respect to these issues, must be adhered to.
- 3. Fire extinguishers, panic hardware, and emergency lighting are required. The building must meet all AR state fire code and ADA requirements. A statement from the applicant, owner, architect or engineer must be submitted prior to the building being occupied that says the building, parking, access, and restrooms are in compliance with all ADA regulations.
- 4. The Fire Marshal will inspect the site and building prior to operation.

Roads/Sight Visibility/Ingress-Egress/Parking Conditions:

1. If the aprons were not paved as approved with the previous church expansion, they must be paved prior to the occupation of this building.

Environmental Conditions:

1. At this time, no stormwater permit is required by Washington County; however, the applicant must comply with all rules and regulations of the Arkansas Department of Environmental Quality (ADEQ).

Utility Conditions:

1. Generally, any damage or relocation of utilities will be at the expense of the owner/applicant. There is no gas or cable service to this property.

Signage/Lighting/Screening Conditions:

- 1. No additional signage or lighting is proposed with this project.
- All outdoor lighting must be shielded from neighboring properties. Any lighting must be indirect and not cause disturbance to drivers or neighbors. All security lighting must be shielded appropriately.

Standard Conditions:

Pay neighbor notification mailing fees (\$61.95) within 30 days of project approval. Any extension must be approved by the Planning Office (invoice was emailed to applicant on

- 2. Pay engineering fees within 30 days of project hearing. This is usually calculated at Final LSD Plan.
- 3. Hours of operation should be generally as approved with project 2012-067.
- 4. Any further splitting or land development not considered with this approval must be reviewed by the Washington County Planning Board/Zoning Board of Adjustments.
- 5. This CUP must be ratified by the Quorum Court.
- It is the applicant's responsibility to contact the Planning Office when inspections are needed.
- All conditions shall be adhered to and completed in the appropriate time period set out by ordinance.
 - This project requires additional review (Subdivision or Large Scale Development), and therefore, the applicant must submit for Preliminary project review within 12 months of this CUP project's ratification.

^{*} County Ordinance allows for an appeal period (for any party: applicant, neighbor, member of the public, etc) within 30 days of the Planning Board/ZBA approval. Even if the Quorum Court ratifies the CUP; the right of appeal remains until the 30 days has passed. If an appeal is filed within the 30 day period then a subsequent hearing will be scheduled and held by the Quorum Court.*
