County Judge Joseph K. Wood called the meeting to order.

JP Harvey Bowman led the prayer and pledge.

Washington County Library System 2018

The Washington County Library System (WCLS) is primarily funded by a one mill levy on real and personal property tax that was passed in the November 1948 General Election. The millage and additional funding is distributed to the member libraries by the Washington County Library System Board. Six municipal and two branch libraries are members of the system. The municipal libraries are located in the cities of Elkins, Farmington, Lincoln, Prairie Grove, Springdale, and West Fork. The cities of Greenland and Winslow provide facilities for the branch libraries, while WCLS provides the materials and staff.

While approximately 20% of budgeted expenditures are used to staff the administrative office and provide services to the member libraries, the remaining 80% of the budgeted monies are distributed directly to the member municipal libraries and used to provide staff and materials for the two branch libraries.

The eight member libraries of the Washington County Library System checked out more than 1 million items annually between 2008 and 2017 and are on track to do the same in 2018. Libraries around the nation have been seeing declining circulation numbers in recent years while actually seeing more users in the libraries. Check outs of digital materials in 2017 (e-books and downloadable audiobooks) increased 6.4% over 2016.

Member libraries own over 385,000 physical items that are available for use by all county residents. Patrons of the system have access to 41,800 ebooks and 10,774 downloadable audiobooks through the Arkansas Library2Go Consortium.

4.5 FTE staff currently work for the Washington County Library System. Our primary function is to provide funding and services to the member libraries under the auspices of the Washington County Library Board. This is achieved with a full-time director (Glenda), full-time interlibrary loan librarian/administrative assistant, (Georgia) and a full-time catalog clerk/Greenland Branch clerk (Terri). In addition to the full-time staff, we have a part-time processing clerk (Nicky), a part-time courier (Gary), and two part-time branch clerks at Winslow (Carolyn and Jean). The three branch clerks operate and staff the Greenland and Winslow branches under the supervision of the director. We also have two volunteers: Norma comes in twice a week to cover books with plastic jackets and George does special volunteer projects for us as needed.

Daily services provided to the libraries and their patrons include the provision and maintenance of the automated checkout system and online catalog and its content while providing user support for those systems. Interlibrary loan services allow patrons to request materials that are not available locally to be sent from other libraries in the United States for checkout from their local library at no cost. We reciprocate this service by loaning materials from our libraries to other libraries across the country. We provide cataloging and processing of materials for the libraries that choose to use that service. We provide a daily courier who transports materials between libraries so that patrons can borrow materials from other libraries in the system and return their materials to any library in the system. Staff provides general support to the libraries on a variety of topics. In addition to these services, the Greenland and Winslow Branch libraries are

staffed 20 and 28 hours per week respectively. We also select, purchase, and process books, DVDs, and audiobooks for those branches. We also, as a member of the Arkansas Library2Go digital library consortium, select and purchase downloadable audiobooks and ebooks for use by system patrons.

Washington County Library System in 2017 provided children's services ranging from pre-school to young adult programs for the seven smaller member libraries. With the prospect of the Children's Librarian's (Sherry) retirement in January 2018, it was decided that in order to provide the member libraries more autonomy over their children's programming by splitting the salary of the Children's Librarian between the five smaller municipal libraries so they could they could provide their own programming. This gave them the ability to design their programs to better fit their communities and their libraries. We will continue that funding into the future.

The Washington County HIV Clinic was started in 1992 as a result of a county wide task force recommendation.

During the past **26** years our case load has grown from the original 31 patients enrolled in the first year of operation to a total of 1017.

The rate of growth in enrollment follows the rate of growth of the population in Northwest Arkansas. From 2008 – 2018 we grew from 636 to 1017, an increase of almost 40%.

During the past four years medications have been released that can effectively treat Hepatitis C. Many of our clients are co infected with Hepatitis C. We have access to federally funded medications for Hepatitis C treatment and have started providing these medications as well as HIV treatment for our co infected patients. We have successfully cleared Hepatitis C from 12 patients.

The Planning Board/Zoning Board of Adjustments approved Wholesale Motorcars CUP, with conditions, request on November 1, 2018 (6 members voted "in favor", 0 members voted "against", 1 member was absent).

- 2. Three computers and several printers had to be replaced and we had to move \$3,310 to the computer/ IT equipment line item to pay for these purchases;
- 3. Three of our Juvenile Officers/Specialized Police Officers needed safety vests and we did not budget that expense in the 2018 budget; therefore, a total of \$2,100 had to be transfer to the line item 2012 Bullet Proof Vest.

I hope this addresses your concerns.

APPROPRIATION ORDINANCE:

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF WASHINGTON, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE RECOGNIZING REVENUES AND APPROPRIATING MONIES FOR THE EXPENDITURES IN EACH FUND FOR WASHINGTON COUNTY, ARKANSAS, FOR THE YEAR 2019, AND ADOPTING A BUDGET FOR THE VARIOUS DEPARTMENTS REFLECTING THE LINE ITEM EXPENDITURES THEREOF.

BE IT ORDAINED BY THE QUORUM COURT OF WASHINGTON COUNTY, ARKANSAS:

ARTICLE 1. The Quorum Court of Washington County, Arkansas, has prepared a County Budget for the Year 2019 for all funds, said budget reflecting the anticipated revenues of Washington County and the line item expenditures authorized for each department within each fund of said County, the number and compensation of deputies and County employees and the compensation of County Officers.

ARTICLE 2. A copy of the said 2019 Budget for each fund with approved amendments shall be on file in the County Clerk's Office.

ARTICLE 3. The said 2019 Budget is hereby incorporated herein and adopted in full, and all expenditures reflected therein are authorized to be expended.

ARTICLE 4. The 2019 Budget Controls are hereby adopted and incorporated herein as if set out word for word.

ARTICLE 5. The Collector's Unapportioned Fund is a fund separate and apart from the above funds as administered by the County.

ARTICLE 6. If any part of this Ordinance is held invalid, such invalidity will not affect any other portion of this Ordinance.

ARTICLE 7. All laws and parts of law in conflict with this Ordinance are repealed.

2019 BUDGET CONTROLS

It is the responsibility of each elected official and/or department head to operate within the guidelines of the budget as adopted or amended by the Quorum Court. The guidelines are described in the following paragraphs:

The budget for each County department consists of appropriations of authorized expenditures in the following major categories:

- 1. Personal Services (Regular Salaries, Extra Help, Overtime & Fringe)
- 2. Supplies
- 3. Other Services and Charges
- 4. Capital Outlay
- 5. Debt Service
- 6. Interfund Transfers

Expenditures will be limited to the amounts appropriated in the above categories.

- 1. Transfers in Personal Services categories or transfers between departments may only be made by Ordinance.
- 2. Line item transfers within a departmental budget may be made within and into all categories, with the exception of the Personal Services Category as outlined in Budget Control #1 and with the exception that no funds shall be transferred out of the Fuel, Oil, and Lubricants Line Item without the approval of the Quorum Court. Transfers going into or out of the Capital Outlay Category shall not exceed \$5,000 per year in the General Fund, excluding the County Judge-Emergency Budget; any transfers exceeding this limit will require approval of the Quorum Court. Excluding grant funds, Line Item Transfers will cap at \$15,000 or 3% of a department's operating budget per single transfer. Annual total line item transfers may not exceed 10% of operating budget; any transfers exceeding this limit will require approval of the Quorum Court. With the exception of grant funds, no department may purchase supplies or other services and charges for another department except for utilities and cleaning and maintenance services provided by the Buildings & Grounds Department aggregated into the general budget. This does not apply to departments who work together in cost sharing projects.
- 3. Appropriations for use of grant funds must be made by ordinance with a grant agreement approved by the County Judge. All personnel positions funded by grants will be annotated as such and may be abolished upon expiration of the grant. The Quorum Court must approve in-kind cost for grants prior to grant acceptance. All Grants will be administered through the County Grants Administration Office with all billings and financial reporting being handled in the Comptroller's Office.

- 4. All approved purchases must be made with a Purchase Order or P-Card and follow the written purchasing procedures as outlined by the County Judge.
- 5. The Comptroller will transfer monies monthly from individual departmental budgets into the Insurance Benefit Fund for all full time positions and qualifying part time employees regardless of whether all positions in the departments are filled.
- 6. All full-time employees who qualify for annual leave will receive a 3.0% pay increase effective the first pay check of 2019. Full-time employees with less than one year's service shall receive a 3.0% pay increase upon his/her anniversary date. Maximum salary caps in all grades shall be suspended for the 2019 Budget Year.

Full-time Elected Officials shall receive a pay increase based on years of elected service as outlined below and shall go into effect the first pay check of 2019.

1st Year 80% of the range for that year
2nd Year 82.5% of the range for that year
3rd Year 85% of the range for that year
4th Year 87.5% of the range for that year
5th Year 90% of the range for that year
6th Year 92.5% of the range for that year
7th Year 95% of the range for that year
8th Year 97.5% of the range for that year
9th Year 100% of the range for that year
Each Additional year 2.5% increase of the 100% for that year

7. The County Judge-Emergency Budget monies are not to be granted to individual citizens but are to be used to pay for expenses incurred by the County in assisting the citizens at large when the County Judge has declared an emergency pursuant to A.C.A.§12-75-101, et seq.
