Re: 2021 Budget Requests

This letter is to give the Committee information regarding adjustments to the budget for the Circuit Clerk's office for 2021. In reviewing the previous year's budget for this department, I have been able to trim \$163,000.00 from the 2020 budget as a projection for the 2021 budget.

With reducing spending in 2020 due to the COVID-19 pandemic, along with the proactive need for separation in the office in preparation for future events, I have budgeted \$50,000.00 in the Capital Outlay line item for a renovation of the front office area. This would include some changes in the physical layout in three areas of the front allowing structural walls and glass to be installed for a more efficient and safe working environment for our staff.

It is my hope that my history of being able to continually make efficiency adjustments in our office so that we can lower costs each year will be considered for this request. I feel that this is a necessary project that needs to be addressed as soon as possible and not later.
