ORDINANCE NO. 2020-1 2 BE IT ENACTED BY THE QUORUM 3 OF THE COUNTY COURT 4 WASHINGTON, STATE OF ARKANSAS, 5 AN ORDINANCE TO BE ENTITLED: 6 7 AN ORDINANCE SETTING CONTROLS FOR 8 THE 2021 BUDGET. 9 10 WHEREAS, the Washington County Quorum Court wishes to 11 promote predictability and efficiency in the 2021 budgeting process; and, 12 13 WHEREAS, Washington County projects \$104,237,795 14 \$44,088,452 in total revenues in the County General Fund for 2021; and, 15 16 **WHEREAS**, after the state required holdback, Washington 17 County may appropriate the total amount of \$96,205,575 \$39,679,607 for County General 18 Fund expenses in 2021; and, 19 20 WHEREAS. Washington County desires to appropriate 21 increase County Reserves to \$5,000,000 \$1,000,000 to the County Reserves and to 22 increase the County Emergency Fund Budget to \$500,000 to the County Judge's 23 Emergency Fund, prior to any appropriation for expenditures for 2021; and, 24 25 WHEREAS, Washington County desires to appropriate the 26 total amount of \$85,734,654 in expenditures for 2021; and, 27 28 WHEREAS, Washington County desires to adopt a method 29 30 which appropriates monies to elected officials according to fixed percentages. 31 NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM 32 33 **COURT OF WASHINGTON COUNTY, ARKANSAS:** 34 35 ARTICLE 1. The Quorum Court of Washington County hereby appropriates \$1,000,000 to be placed in County Reserves. The Quorum Court of 36 Washington County hereby determines that it will make available the total amount of 37 \$33,179,607 to budget in the County General Fund for 2021. 38 39 40 ARTICLE 2. The Quorum Court of Washington County hereby appropriates \$500,000 to be placed in the County Judge's Emergency Fund. 41

e. <u>Circuit Cierk.</u>

ARTICLE 3. The Quorum Court of Washington County hereby appropriates sufficient monies to satisfy both employee raises and cost-of-living adjustments, for the 2021 budget.

ARTICLE 4. The Quorum Court of Washington County hereby appropriates sufficient monies for any fund that is not expressly identified herein; those expenditures shall be presented and approved by the Quorum Court on a case-by-case basis.

ARTICLE 5. The Quorum Court of Washington County shall execute articles 1-4 prior to the execution of article 6.

ARTICLE 6. The Quorum Court of Washington County, subsequent to the preceding articles, shall appropriate any remaining monies in accord with the following percentages:

Public Defender	1.0 <u>1.9</u> %
Election Commission	0.7 <u>0.8</u> %
Coroner	0.5 <u>1.1</u> %
Treasurer	0.5 0.5%
Quorum Court	0.3 0.6%

ARTICLE 7. All proposed budgets that are consistent with the aforementioned percentages, shall be approved automatically by the Washington County Quorum Court.
