Said budget reflects the anticipated revenues of Washington County and the expenditures authorized for each department within each fund of said County, the number and compensation of deputies and County employees, and the compensation of County Officers.

The budget for each County department consists of appropriations of authorized 42 expenditures in the following major categories: 43 44 Personal Services (Regular Salaries, Extra Help, Overtime & Fringe) 45 Supplies 46 Other Services and Charges 47 Capital Outlay 48 Debt Service 49 Inter-fund Transfers 50 51 Expenditures will be limited to the amounts appropriated in the above categories. 52 53 Transfers in Personal Services categories or transfers between departments may 54 only be made by Ordinance. 55 56 Grant funds are not subject to the restrictions in this paragraph. Line item transfers 57 within a departmental budget may be made within and into all categories, with the 58 exception of the Personal Services Category as outlined in Budget Control #1. Transfers 59 going into or out of the Capital Outlay Category shall not exceed \$20,000 per year in the 60 General Fund, excluding the County Judge-Emergency Budget; any transfers exceeding 61 this limit will require approval of the Quorum Court. No department may purchase supplies 62 or other services and charges for another department except for utilities and cleaning and 63 maintenance services provided by the Buildings & Grounds Department aggregated into 64 the general budget. This does not apply to departments who work together in cost sharing 65 projects. 66 67 Appropriations for use of grant funds must be made by ordinance with a grant 68 agreement approved by the County Judge. All personnel positions funded by grants will 69 be annotated as such and may be abolished upon expiration of the grant. The Quorum 70 Court must approve in-kind cost for grants prior to grant acceptance. Surplus personnel appropriations shall be de-appropriated from Full-time Salaries on a quarterly basis (April/July/October). These surplus funds shall be restored to unappropriated reserves.

All full-time employees who qualify for annual leave will receive a pay increase of 86 \$1,560 divided into 26 payments of \$60.00, effective the first pay check of 2021. Full-time 87 employees with less than one year's service shall receive the pay increase upon his/her 88 anniversary date. Maximum salary caps in all grades shall be suspended for the 2021 89 Budget Year. The Sheriff "step" positions will receive the raises as passed by the Quorum 90 Court in 2018 instead of the flat pay increase. Salaried positions within the Sheriff "step" 91 system will receive the same flat pay increase that other full-time employees in the County 92 receive. 93

- Full-time Elected Officials shall receive a pay increase based on years of elected service as outlined below per Ordinance No. 2016-68 and shall go into effect the first pay check of 2021.
