WHILE IN DETENTION YOU HAVE RIGHTS

TO COMMUNICATE: You have the right to contact parents or guardians and to have them visit you here.

TO HAVE PROPERTY: You have the right to your valuables and other possessions protected, stored, and returned to you upon release.

TO BE SAFE AND SECURE: Neither staff nor any residents have the right to strike you, inflict physical harm, or verbally abuse you. You may, however, be restrained if your actions are a threat to you or another's safety. Unwanted physical or sexual advances toward you are also a violation of your rights. If you are abused or violated by anyone during your stay, report it to staff immediately.

TO KNOW WHY YOU ARE DETAINED: You must be given a written statement of the charges against you before your hearing in court.

TO HAVE LEGAL COUNSEL: You have the right to talk to and be represented by an attorney. If you or your family cannot afford an attorney, the court must provide one for you and give you time to talk with him/her before your hearing.

TO REMAIN SILENT: You cannot be required to discuss your charges with anyone. Anything you say during intake and while you are in detention may be used against you in legal proceedings. You have the right not to testify against yourself and you cannot be required to present evidence against yourself at your hearing.

NOT TO BE HELD WITH ADULTS: In most cases, it is illegal for anyone under 18 to be detained in the same place with adult inmates. If youths and adults are held in the same facility, there must be complete separation between adult and juvenile detainees.

TO MEDICAL CARE: You have the right to medical attention. Report special health problems, or medication requests, to detention staff.

TO BE HEARD: You have the right to a detention hearing within 72 hours of your intake at detention or on the next business day if the 72 hours end on a weekend or holiday. The judge will decide if you will be detained for a longer period. If your case goes for trial before a judge, you have the right to present witnesses in your defense.

Visitation is by appointment only. Your parent or guardian must call staff to schedule an appointment for Saturday or Sunday, depending on your status, between 8am and 5pm Monday-Friday. If you are unsure of your status, please speak with detention staff.

TO CONTACT YOUR ATTORNEY, MAKE A REQUEST THROUGH DETENTION STAFF. THEY WILL CONTACT YOUR ATTORNEY'S OFFICE AND INFORM THEM OF YOUR REQUEST TO SPEAK TO HIM/HER. IT WILL BE UP TO YOUR ATTORNEY TO VISIT YOU WHILE YOU ARE DETAINED.

Staff will not call your Probation Officer or Caseworker. They will contact you.

LETTER WRITING IS TO PARENTS OR GUARDIANS ONLY.

One letter may be written or mailed from the facility each day.

PHONE CALLS ARE TO PARENTS OR GUARDIANS ONLY.

Residents may make one 15 minute phone call daily from 6:00pm to 8:00pm.



- Follow all staff directives immediately.
- 2 No physical contact of any kind is permitted.
- 3 Cursing, disrespectful language, talking to residents of other statuses, talking through doors/walls, and whistling are not permitted.
- **4** Discussion of gang activities, throwing gang signs, and writing or drawing anything gang related is not permitted.
- **5** Do not discuss your charges or anyone else's charges with other residents.
- **6** Discussion of escape is not permitted.
- Tobacco use or discussion of such activities is not permitted.
- **8** Do not touch any electrical appliances.
- **9** Do not take any writing utensils or food into your room.
- Always ask detention staff if you are unsure about what you are supposed to do.

YOUR BEDROOM

- ① Keep your room clean.
- ② Your bed must be made before you leave your room to enter the pod.
- ③ There will be no tolerance of vandalism to the walls, bed, doors, etc.
- ④ Your shoes must remain outside your room at all times.

10:00 Lights out time

USING THE INTERCOM BUTTON IN YOUR ROOM

The intercom button is in your room so that detention staff may speak with you and so that you may speak with staff. Do not use the intercom to ask the time of find out when you may come out of your room.

You are ordered by the judge to attend school while you are in JDC.

There is no tolerance for inappropriate behavior during school hours. If you do not participate in school activities, or if you act inappropriately, you will be sent to your room for the remainder of the day. Refusal of school will be documented and reported to Juvenile

YOU WILL BE HELD ACCOUNTABLE

DOORS, OR OTHER PROPERTY.

HYGIENE

YOU MAY USE YOUR HYGIENE ITEMS UPON REQUEST AFTER BREAKFAST AND AT BEDTIME.

You must leave your toothbrush, comb, and deodorant in your hygiene bag at all times.

Please inform staff immediately if these items become worn or damaged as you will be held accountable for missing pieces or missing items.

OTHER RULES:

- You may request to fill out a Grievance Form, Visitor Request Form, or a Special Request Form immediately after lunch. You will receive the form after school that day.
- ② Both uniform shirts must be worn whenever you are out of your room. Both shirts must be tucked in at all times.
- Anytime you are in the pod, you must not cross the black and yellow line. If you have a question, stand behind the line and raise your hand in the shape of a fist. If you need your room door open, stand behind the line and hold up your room number.
- Whenever you see or hear a pod door open, you must stand up against the wall immediately and wait for staff instructions.
- **9** Do not give away or trade any of the food items that are given to you for any reason.
- **6** Only one person is allowed on the pod stairs at a time.

TOILET PAPER: You will be given one roll of toilet paper upon intake. If you run out, keep the empty cardboard roll to exchange for a new roll.

DO NOT USE TOILET PAPER AS SPIT WADS OR MAKE TOYS FOR ANY REASONS.
