MEETING June 28, 2023 MINUTES

A meeting of the Fourth Judicial District Drug Task Force Control Board was held on June 28, 2023.

Chief Mike Reynolds called the meeting to order. Upon roll call, the above-listed members were acknowledged as present. Copies of the minutes from May 10, 2023, meeting were distributed to all present. A motion was made by Chief Frank Gamble and seconded by Captain Ti Augustine to approve the minutes. The motion was approved unanimously.

A copy of the financial report for the Grant FY2022-2023 was distributed to all present for review, the period ending May 31, 2023. Tonyia Tannehill stated the total expense to date was \$492,894.00 which included Federal 235041-21AJ \$ 21,098.00, Federal 235041-22JL \$62,232, State 235041-22JL \$43,597.00, State J23-004-DF \$91,319.00, Local 235041-22JL \$18,670.00, Local J23-004-DF \$27,396.00, and Non-Allowed-\$228,582.00.

Sergeant Jacob Lawson reported on the task force's activity from May 1, 2023, through May 31, 2023, and he distributed a copy of statistics to all present. Lawson stated that in May the task force opened 31 cases, closed 34 cases, and made 18 arrests. Lawson further noted that \$4,900.00 was expended for the purchase of evidence and \$700.00 for the purchase of information. Lawson stated that drugs seized during the month included: methamphetamine, marijuana, cocaine, psilocybin mushrooms, MDMA, fentanyl, and pharmaceuticals. Lawson stated that 7 warrants were served. Also noted, were 10 drug convictions for May. The task force seized \$22,004.00 U.S. currency during the month. The locations of DTF Enforcement Action for the month were Fayetteville 19 cases, Springdale 8 cases, Greenland 1 case, Farmington 2 cased, and Washington 1 case.

Sergeant Jacob Lawson reported on the following dispositions.

DTF 19-409 (State of Arkansas v Joshua Hogue) was a Drug Task Force arrest in Springdale resulting in the seizure of \$4,465.00 on December 3, 2019. \$893.00 went to the Arkansas State Drug Director's Office and \$1,339.50 went to the Washington County Prosecutor's Office Drug Control Fund. It was recommended that 15% of the net total of \$2,232.50 go to the Drug Task Force and the remaining balance be based on current staffing (Springdale 50%, Fayetteville 25%, WCSO 12.5% and Rural 12.5%).

Notes:

On December 3, 2019, detectives with the Drug Task Force searched the vehicle of Joshua Hogue in Springdale after arresting him for felony warrants. The search revealed methamphetamine, marijuana, pharmaceutical pills, two firearms and drug paraphernalia indicative of the sale of methamphetamine along with the currency.

Chief Mike Gamble, seconded by Chief Chris Workman, made a motion to approve this recommendation. The motion was passed unanimously.

DTF 22-326 (State of Arkansas v Kevin Burke) was a Drug Task Force arrest in Springdale resulting in the seizure of \$1,504.00 on December 14, 2022. \$300.80 went to the Arkansas State Drug Director's Office and \$451.20 went to the Washington County Prosecutor's Office Drug Control Fund. It was recommended that 15% of the net total of \$752.00 go to the Drug Task Force and the remaining balance be based on current staffing (Springdale 37.5%, Fayetteville 37.5%, WCSO 12.5% and Rural 12.5%).

Notes:

On December 14, 2022, detectives with the Drug Task Force arrested Kevin Burke for multiple counts of Delivery of Methamphetamine. A subsequent search of his vehicle revealed approximately three-quarter pound methamphetamine and a loaded firearm along with the currency.

Chief Chris Workman, seconded by Chief Frank Gamble, made a motion to approve this recommendation. The motion was passed unanimously.

DTF 22-357 (State of Arkansas v Danny Dooly) was a Drug Task Force arrest in Springdale resulting in the seizure of \$3,699.00 on November 29, 2022. \$739.80 went to the Arkansas State Drug Director's Office and \$1,109.70 went to the Washington County Prosecutor's Office Drug Control Fund. It was recommended that 15% of the net total of \$1,849.50 go to the Drug Task Force and the remaining balance be based on current staffing (Springdale 37.5%, Fayetteville 37.5%, WCSO 12.5% and Rural 12.5%).

Notes:

On November 29, 2022, detectives with the Drug Task Force searched the residence of Danny Dooly. The search revealed approximately one-quarter pound methamphetamine, pharmaceutical pills, one stolen firearm and drug paraphernalia indicative of the sale of methamphetamine along with the currency.

Lieutenant Ti Augustine, seconded by Chief Frank Gamble, made a motion to approve this recommendation. The motion was passed unanimously.

DTF 23-011 (State of Arkansas v Reed Cook) was a Drug Task Force investigation in Washington County resulting in the seizure of \$5,890.00 on January 23, 2023. \$1,178.00 went to the Arkansas State Drug Director's Office and \$1,767.00 went to the Washington County Prosecutor's Office Drug Control Fund. It was recommended that 15% of the net total of \$2,945.00 go to the Drug Task Force and the remaining balance be based on current staffing (Springdale 37.5%, Fayetteville 37.5%, WCSO 12.5% and Rural 12.5%).

Notes:

On January 23, 2023, detectives with the Drug Task Force searched the residence of Reed Cook after conducting several controlled purchases of methamphetamine from him. The search revealed approximately one-quarter pound of methamphetamine and drug paraphernalia indicative of the sale of methamphetamine along with the currency.

Chief Mike Gamble, seconded by Lieutenant Ti Augustine, made a motion to approve this recommendation. The motion was passed unanimously.

DTF 23-037 (State of Arkansas v Mitchell Nwachukwu) was a Drug Task Force investigation in Fayetteville resulting in the seizure of \$2,286.00 on February 7, 2023. \$457.20 went to the Arkansas State Drug Director's Office and \$685.80 went to the Washington County Prosecutor's Office Drug Control Fund. It was recommended that 15% of the net total of \$1,143.00 go to the Drug Task Force and the remaining balance be based on current staffing (Springdale 37.5%, Fayetteville 37.5%, WCSO 12.5% and Rural 12.5%).

Notes:

On February 7, 2023, detectives with the Drug Task Force searched the residence of Mitchell Nwachukwu in Fayetteville after receiving information he was selling controlled substances. The search revealed approximately nine pounds of marijuana in multiple bags and drug paraphernalia indicative of the sale of marijuana along with the currency.

Chief Mike Gamble, seconded by Chief Chris Workman, made a motion to approve this recommendation. The motion was passed unanimously.

DTF 23-037 (State of Arkansas v Mitchell Nwachukwu) was a Drug Task Force arrest in Fayetteville resulting in the seizure of \$1,013.00 on March 9, 2023. \$202.60 went to the Arkansas State Drug Director's Office and \$303.00 went to the Washington County Prosecutor's Office Drug Control Fund. It was recommended that 15% of the net total of \$507.40 go to the Drug Task Force and the remaining balance be based on current staffing (Springdale 37.5%, Fayetteville 37.5%, WCSO 12.5% and Rural 12.5%).

Notes:

On March 9, 2023, detectives with the Drug Task Force again searched the residence of Mitchell Nwachukwu in Fayetteville after receiving information he was still selling controlled substances. The search revealed approximately three pounds of marijuana in multiple bags and drug paraphernalia indicative of the sale of marijuana along with the currency.

Lieutenant Ti Augustine, seconded by Chief Frank Gamble, made a motion to approve this recommendation. The motion was passed unanimously.
