

BACKGROUND/SYNOPSIS

The applicant is requesting a conditional use permit to operate a warehouse/flex space for business and contractors in the area. Currently, the parcel of land is 17.29 acres, but a tract split is in progress to split off a five (5) acre parcel for the business. Approximately two (2) acres will be used for the project.

There are currently 2 buildings on the property, each under 12,000 sq ft with units between 600 and 2,400 sq ft in size. The units will be occupied by a variety of tenants, and parking to accommodate them surrounds each building. There are twenty (20) parking spaces on each side and an additional twelve (12) parking spaces between the buildings. All parking is asphalt paved and ADA accessible.
