
**ORDER**

Now on this 17 day of November, 2015 comes on for hearing the matter of the awarding of the bid for Insurance on Workers Compensation, Automobiles, Buildings and Contents for Washington County, by Washington County, Arkansas, and from various bids submitted, and other things, matters and proof before the Court, the Court finds:

1. That the procedure for soliciting bids was properly followed as outlined in Statute ACA 14-22-101 et seq.
2. That the lowest and most responsible proposal for Building, Contents, ECP, Fidelity/Fiduciary Bonds & Insurance, and Excess Property coverage was submitted by Brown & Brown Insurance and upon recommendation by Nelson Driver of Arkansas Risk & Insurance Services, Inc. should be approved.
3. That the lowest and most responsible proposal for Vehicles, Heavy Equipment, Liability Protection, and Workers Compensation Insurance was submitted by AAC Risk Management and upon recommendation by Nelson Driver of Arkansas Risk & Insurance Services, Inc. should be approved.
4. That bidder agrees to meet all specifications as outline in RFP 2015-01

Judge Edwards,

After careful review & negotiation on the Property Bids, it is my recommendation that the bids be awarded as follows:

Vehicles, heavy equipment, the liability protection and Workers Compensation be awarded to AAC Risk Management.

Buildings, contents, EDP, Fidelity/Fiduciary Bonds & Insurance, Excess Property coverages be awarded to Brown & Brown Insurance.

I have negotiated the split-out in coverages with both bidders and they have agreed with the terms. This will lower the deductible on the heavy equipment from the present \$15,000 to \$1,000 and the premium will be within my submitted budget for 2016.

Once I have your approval, I will officially notify the parties concerned.
